He noted that in order to participate in the event a flyer is needed and available at City Hall or on the City's website. He requested information on the Business Licensing. The City Manager responded that there are several issues that are being worked out and that a report would be brought back at the next meeting. The Mayor then noted that he too had participated in Principal for a Day. He then noted that the City Council had met with Congressman Ken Calvert regarding the Hamner Bridge. He reported that Congressman Calvert was supportive of the City's position and behind the City in its endeavors regarding the bridge. The Mayor then noted that he is a board member for the Community Foundation. He noted that his job as Mayor takes a lot of time and would like the Council to consider a replacement for him on the board.

11. CITY MANAGER'S REPORT:

The City Manager reported that the VLF bill had been submitted and there may be a necessity to go to Sacramento after April 9, 2012 to testify on behalf of the bill.
