He also noted a meeting on January 24, 2012 with JCSD to coordinate an events calendar. City Manager Van Nort encouraged all organizations with upcoming events to attend.

Councilmember Welch noted that he attended many events during the holiday season.

Councilmember Rush noted that he attended a presentation on Measure A funds and that revenue is up 9%. He also added that SB244 will have impacts to the City's General Plan, specifically the Housing and Land Use Elements. He also noted that Corky's Restaurant accepts donated coffee mugs and that this would be good Advertisement for the City's businesses.

Mayor Pro Tem Howell offered her thanks to City staff for going above and beyond. She also noted that she really appreciates Captain Feltenberger's efforts on behalf of the City of Eastvale.
