1. *CALL TO ORDER:* 6:30 p.m.

#### 2. ROLL CALL/PLEDGE OF ALLEGIANCE/INVOCATION:

Planning Director Norris provided a brief PowerPoint presentation on the item.

7.1 Public Hearing – Change of Zone and Conditional Use Permit No. 10-0058; for development of a church – north of A Street (future Schleisman Road) and west of Hamner Avenue (Future New Day Church Site).

There was discussion regarding the time frame for the contract, the training of the Board Members of the Community Foundation, and the amount, use and method of awarding the grant funds.

## 8.2 Reclassification – Deputy City Clerk; Code Enforcement Officer.

Recommendation: Adopt Resolution 12-40, entitled:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EASTVALE, CALIFORNIA, APPROVING JOB DESCRIPTIONS AND SALARY RANGES FOR CODE ENFORCEMENT SUPERVISOR AND ASSISTANT CITY CLERK, AND AUTHORIZING THE CITY MANAGER TO FILL THE POSITIONS.

City Manager Van Nort provided the staff report.

Motion: Moved by Howell, seconded by Rush to approve the item as presented.

Motion carried 5-0.

City Manager Van Nort added that a County Code Enforcement Officer would be assisting the City while the recruitment for the Code Enforcement Supervisor was occurring.

#### 9. NEW BUSINESS ITEMS:

## 9.1 Development Agreement for a Freeway-Oriented Electronic Billboard.

<u>Recommendation:</u> Schedule a public hearing to consider approving an agreement with General Outdoor Signs.

Planning Director Norris provided a staff report.

City Manager Van Nort stated that it was anticipated that the Agreement would contain language that would provide 10% of the profits the City received from the sign to the Community Foundation and 10% of the profits to the Eastvale Chamber of Commerce.

Council Member Welch had a concern with providing the Community Foundation with additional funds before they had a solid action plan.

Motion: Moved by Howell, seconded by Welch to approve the item as presented.

Motion carried 5-0.

# 9.2 Contract for IT Support Services.

<u>Recommendation:</u> Approve Synoptek proposal to enter into a contract for IT Services in an amount of \$23,620 annually.

Public Information Officer Nissen provided a staff report on the item.

The various aspects of the contract were discussed.

Motion: Moved by Howell, seconded by Welch to approve the contract as staff recommended in an amount not to exceed \$23,620 annually.

Motion carried 5-0.
