## PLANNING COMMISSION NOTICE OF PUBLIC HEARING AND NOTICE OF AVAILBILITY FOR PROJECT NO. 93206 – LIMONITE GAP CLOSURE DRAFT MITIGATED NEGATIVE DECLARATION

NOTICE IS HEREBY GIVEN that the City of Eastvale Planning Commission will hold a public hearing on <u>Wednesday</u>, June 17, 2020, at 6:00 p.m. at the Eastvale City Hall Council Chambers located at 12363 Limonite Ave., Suite 900, Eastvale, CA 91752, to consider the adoption of a Mitigated Negative Declaration (IS/MND) for the Limonite Gap Closure Capital Improvement Project (Project). The project includes the construction of a four-lane roadway along the Limonite corridor, multi-use trails/bike lanes along the north and south side of the proposed road improvements, vehicular bridge and pedestrian structures crossing the Cucamonga Creek Channel, and a multi-lane roundabout. The Planning Commission will serve as a recommending body to the City Council.

A DRAFT MITIGATED NEGATIVE DECLARATION (IS/MND) for the proposed project, as described above, has been completed and is now available for public review. The IS/MND evaluates potentially significant adverse environmental impacts that could be associated with the Project and identifies project components, scope and mitigation measures, that would avoid, reduce, or eliminate significant impacts. The IS/MND does not set forth policy for the City of Eastvale about the proposed Project's desirability. Rather, it is an information document to be used by decision-makers, public agencies, and the public, in accordance with the California Environmental Quality Act (CEQA).

If you challenge the project in court, you may be limited to raising only those issues you raised at the public hearing as described in this notice or in written correspondence delivered to the Eastvale Planning Commission prior to or at the public hearing.
