The fully burdened rate is determined by multiplying the total wages by the sum of the benefit percentage and a cost allocation percentage for City Manager, Finance, Talent Attraction and Development, and Risk Management departments and adding the product to the current hourly rate. Both percentages are determined during the annual budget process, for fiscal year 2020-21 the benefit percentage is 10.15% and the cost allocation overhead percentage is 5.30; fiscal year 2021-22 is 13.89% and 5.233%; fiscal year 2022-23 is 13.75% and 4.29%.

Vendor Charges: The City shall pass through all labor charges from vendors related to an application, based on the time worked and the thencurrent hourly rate of the person performing the work. The rate is determined by multiplying the current hourly rate by the cost allocation for City Manager, Finance, Talent Attraction and Development, and Risk Management departments determined during the annual budget process and adding the product to the current hourly rate. For fiscal year 2020-21 the cost allocation overhead percentage is 5.30%; fiscal year 2021-22 is 5.233%; fiscal year 2022-23 is 4.29%.

Staff Charges: The City shall pass through all labor charges by City employees related to an application, based on the time worked and the employee's then-current fully burdened hourly rate. The current hourly rate of City staff is calculated by adding all wages, including salary, incentive pays, and cafeteria dollars for the given pay period and dividing by 80 hours. The fully burdened rate is determined by multiplying the total wages by the sum of the benefit percentage and a cost allocation percentage for City Manager, Finance, Talent Attraction and Development, and Risk Management departments and adding the product to the current hourly rate. Both percentages are determined during the annual budget process, for fiscal year 2020-21 the benefit percentage is 10.15% and the cost allocation overhead percentage is 5.30; fiscal year 2021-22 is 13.89% and 5.233%; fiscal year 2022-23 is 13.75% and 4.29%.
