1. CALL TO ORDER: 4:04 pm

2. ROLL CALL/PLEDGE OF ALLEGIANCE

Assistant City Clerk Hall called the roll.

Commissioners Present: Commissioners Cruse, Johnson and Vice-Chairman Kiltz.

Commissioners Absent: Commissioner Medrano and Chairman Allis.

Staff Members Present: Police Lieutenant Yates, Fire Chief Mecham, Traffic Engineer Semon, City Manager Jacobs, Assistant City Clerk Hall, Office Assistant Aragon.

Vice-Chairman Kiltz led the Pledge of Allegiance.

3. PUBLIC COMMENT/CITIZEN PARTICIPATION:

None

4. MINUTES:

4.1 Minutes – May 20, 2013 Special Meeting

Recommendation: Approve the minutes from the May 20, 2013 Special meeting.

Motion: Moved by Johnson, seconded by Cruse.

Motion carried 3-0-2 with Commissioner Medrano and Chairman Allis absent.

5. TRAFFIC CONCERNS:

5.1 Ordinance relating to establishing Speed Limits for City Streets.

Recommendation: Receive and File.

Traffic Engineer Semon reported provided a brief staff report on the Speed Survey that was recently conducted.

5.2 Policy on Speed Humps.

Recommendation: Do Not Adopt Policy to Install Speed Humps.

Traffic Engineer Semon provided the staff report for this item.

There was discussion regarding the various types of speed bumps available and other various traffic calming measures with associated costs. Staff did not recommend moving forward with installing speed bumps.

Vice-Chairman Kiltz inquired about the resolution of the traffic issues brought up at the previous meeting.

Traffic Engineer Semon reviewed the contact Staff members had with the resident and the various traffic calming measures that were installed in the neighborhood. He went on to state that there was a two-week grace period for residents to get used to the new traffic laws in the area before enforcement by the police department could be initiated.

Korbin Dorado-Kirscht, a resident, stated that he was happy with the changes in his neighborhood and that he had observed some residents obeying the new laws and others ignoring them.

There was discussion on further recommendations and traffic calming measures.

Vice-Chairman Kiltz inquired about the online survey regarding speeding concerns of the residents and if the results would be shared with the Sheriff's department for additional enforcement.

City Manager Jacobs stated that the survey had been done by the Eastvale News, not the City, and that staff would look into the survey, but did not want to create the perception that the City was obligated to look into all online surveys and respond.

6. NEIGHBORHOOD WATCH:

6.1 Update – Neighborhood Watch Kick-Off Event.

Recommendation: Receive Verbal Update regarding Kick-off Event from Commissioner Medrano.

City Manager Jacobs provided information regarding the Neighborhood Watch Kick-off Event. It had been scheduled for July 19th and the Sheriff's Department, as well as the Fire Department, were confirmed to be at the event. There would be a flyer created and uploaded to the City website regarding the event. She also stated that the City Council was very supportive of the Commission and the Neighborhood Watch Event and also approved the purchasing of shirts with the City Logo for the Commissioners to wear at events.

There was discussion regarding the possibility of the Eastvale Chamber of Commerce finding local businesses to provide food for the event, as well as giveaways for the residents, to help encourage their participation in the Neighborhood Watch Program.

7. EMERGENCY OPERATIONS:

7.1 Update on Emergency Operation Drill Ad Hoc Committee.

Recommendation: Receive verbal update regarding the Table Top Exercise Plans from the Ad Hoc Committee.

Commissioner Cruse reported that the table top exercise is scheduled for July 10th at City Hall from 10am to 12pm. Cal EMA and Riverside OES would be going over the rules and responsibilities of individuals as emergency responders during the exercise.

Commissioner Johnson stated that he is looking forward to seeing the Neighborhood Watch Program grow throughout the City.

Vice-Chairman Kiltz thanked the Sheriff's Department for the work they had done regarding the grow houses in the City.

City Manager Jacobs reported that City Attorney Cavanaugh was looking into policies for registering homes as investment properties and would have a report for the City Council at their June 26th meeting.

There was discussion regarding the new Fire Station location.

There was discussion regarding the Walk to School program and how it would work to help ease traffic congestion around the schools.

There was discussion regarding speaking to the residents and their children about walking to school safely and the danger of strangers.

There was discussion regarding the sidewalk improvements scheduled around Eastvale Elementary School.

City Manager Jacobs also reported that the housing development at the corner of Scholar and Schleisman would be making improvements to the roads in that area.

BACKGROUND:

As a part of the Riverside County Emergency Operations Area, the City of Eastvale is eligible to receive grant funding from the Federal Government for Emergency Management.

DISCUSSION:

Staff has applied for the Emergency Management Performance Grant (EMPG) in order to purchase an electric generator for the City EOC, in order to allow the City to function in an emergency, and for the State Homeland Security Program Grant (SHSP) to completely fund a Community Emergency Response Team training for residents.

FISCAL IMPACT:

The City is now eligible for up to \$24,692 in combined grant funding.

Staff and the Public Safety Commission have been working with the County of Riverside on an Emergency Operations Plan since October 2011. The City originally submitted a final draft for County review in late September 2012.
