Recommendation: Adopt Resolution 13-30, entitled:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EASTVALE, CALIFORNIA, ACCEPTING EASEMENT FOR RIGHT-OF-WAY PURPOSES RELATED TO TRACT MAP 32821 – JOHN C. LEAL & ELIZABETH LEAL TRUST.

Motion: Moved by DeGrandpre, seconded by Howell to approve the Consent Calendar as presented, excluding Item 5.5.

Motion carried 3-0-2 with Welch and Bootsma absent.

City Attorney Cavanaugh provided a brief overview of Item 5.5.

Council Member DeGrandpre discussed the basis for his objection to the ordinance. He did not feel that the ordinance provided enough punishment for those caught with illegal marijuana grow operations in their homes. He discussed various programs that were similar in other cities. He suggested that an alternative to the proposed ordinance and program was to fine homeowners as a penalty for owning a home that was used as an illegal grow house.

There was discussion in regards to continuing this item until all Council Members would be present to discuss.

Motion: Moved by Howell, seconded by Rush to continue the item to the October 23<sup>rd</sup> meeting.

Motion carried 3-0-2 with Welch and Bootsma absent.

There was additional discussion regarding the ordinance.

There was discussion regarding the courts not being willing to uphold fines for homeowners. The City Attorney stated that the ordinance was as aggressive as it could be without compromising the ability to be upheld in court.

There was discussion regarding the Council's ability to make changes to the ordinance after a future adoption, if the program was not working in the intended manner.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EASTVALE AUTHORIZING ESTABLISHMENT OF A CUSTODIAL BANK ACCOUNT WITH MORGAN STANLEY SMITH AND BARNEY AND DESIGNATING THE PERSONS AUTHORIZED TO EXECUTE THE AGREEMENT.

City Manager Jacobs provided the staff report for this item.

There was discussion regarding Morgan Stanley, and the risks and benefits in starting an account.

Motion: Moved by Howell, seconded by DeGrandpre approve the item as presented.

Motion carried 3-0-2 with Welch and Bootsma absent.

8.2 Implementation and Task Force Agreements – Riverside County Storm Water Program.

<u>Recommendation:</u> Approve amended Storm Water Implementation Agreement and TMDL Task Force Agreement, and authorize City Manager to execute on behalf of the City.

City Manger Jacobs provided the staff report for this item.

Motion: Moved by DeGrandpre, seconded by Howell to approve the Implementation and Task Force Agreements as presented.

Motion carried 3-0-2 with Welch and Bootsma absent.

8.3 Renewal of Contract with Riverside County Fire Department for Fire Protection Services in the Amount of \$2,688,037.77 for Fiscal Year 2013-14.

<u>Recommendation:</u> Approve Cooperative Agreement between the County of Riverside and the City of Eastvale in the amount of \$2,688,037.77.

City Manager Jacobs provided staff report for this item.

There was discussion regarding the source of funds and the cost of operating the second fire station.

Motion: Moved by DeGrandpre, seconded by Howell to approve the Renewal of Contract with the Riverside County Fire Department as presented.

Motion carried 3-0-2 with Welch and Bootsma absent.
