7.30 Approve Agreement for Law Enforcement Services between the City of Eastvale, California and the County of Riverside including appointment of the Captain of the Jurupa Valley Station as the City Police Chief.

Interim City Attorney Cavanaugh noted that this item had been discussed at the City Council Elect Work session held on September 29, 2010. After discussion direction was given to staff to bring back language that reflected the concerns of the Council. Interim City Attorney Cavanaugh stated that the Council is aware that the City of Eastvale is required by law to continue services at the level prior to incorporation. However, in the case of the Sherriff contract there is concern on the methodology for determining what that level of service is for the City of Eastvale. He went on to note that staff recommends that the Council move to conditionally approve the contract with the County of Riverside's Sheriff's Department for law enforcement services upon verification and confirmation by staff of the methodology that determined the level of service for the City. He also added that the City Council reserves the right to later amend the Contract.

Council Member DeGrandpre inquired if this was for 94 service hours per day and 19.5 positions. Interim City Manager Van Nort confirmed.
