8.1 Public Safety Outreach, Education and Mitigation Updates (Reports from Police and Public Works Departments)

City Engineer Alvarez summarized the staff report from the Public Works Department.

Mayor Pro Tem Rush asked what the process would be to receive a grant for bicycle helmets.

Public Information Officer Nissen stated that some free bicycle helmets will be provided at the upcoming Bicycle Skills Clinic. She noted that a resident at the Public Safety Commission had suggested contacting the California Highway Patrol (CHP), as they were providing helmets at a recent Bicycle Rodeo event in the City of Claremont. She noted that she will be contacting the Riverside County Office of Health to get some free helmets.

Chief Horton summarized the staff report from the Police Department.

Mayor Pro Tem Rush expressed his appreciation for the staff reports. He asked how much the violation is for not wearing a helmet.

Police Chief Horton stated that he believes it's around \$50.

Public Information Officer Nissen shared a list of upcoming activities in the month of October.

**12.1 PUBLIC EMPLOYEE APPOINTMENT – Government Code Section 54957**


