# **E.1 City Offices**

A progress report was presented by the City Manager, Interwest Grp and Council members DeGrandpre/Welch. The committee is meeting with Lewis Operation Co. to lease the site at 6080 Hamner, Suites 100-102 with options for Suite 103. The Committee will present its findings at the August 18, 2010 meeting.

#### E.2. Furniture

The City Manager with Council-elect DeGrandpre and Interwest Grp described the efforts to secure furniture. The County of Riverside is in the process of approving the City's request for furniture. In addition to the County, Lewis Operation Co. has indicated they have a showroom full of furniture they are willing to sell to the City at pennies on the dollar. A progress report will be given at the next meeting.

The discussion of the Council-elect concluded with the assignment of Council elect DeGrandpe and Welch to visit the Roosevelt High site to determine if their concerns could be resolved.

# **Transition Staff Reports**

Public comments focused on fixing all street and sidewalk liabilities before October 1, 2010; Limonite with water standing in an area that still needs to have a retaining wall constructed.

City Attorney John Cavanaugh updated the Council on the First Agenda (draft) and required training pursuant to State law for Council –elect members.

City Manager Robert Van Nort updated the Council on the transitional status of the proposed staffing for the city, banking services, TLMA. The Council continued all items, except the consensus to appoint Councilelect Howell and Bootsma to the TLMA meeting with the understanding that the meeting should start at or after 4:00 PM.

Council-elect Welch commented that he would appreciate the agendas and any action required to be in the packet prior to the scheduled meetings.
