1. CALL TO ORDER - 6:31 p.m.

2. ROLL CALL/PLEDGE OF ALLEGIANCE/INVOCATION

Councilmembers present: Councilmembers Link, Tessari, and Mayor Pro Tem Rush

Councilmembers absent: Councilmember Welch and Mayor Bootsma

Staff Members present: Acting City Manager Van Nort, City Attorney Cavanaugh, Public Information Officer Nissen, Assistant Police Chief Pemberton, City Engineer Alvarez, and City Clerk Donohue.

Councilmember Welch entered the meeting at 6:32 p.m.

Invocation was led by Chris Reilly with The Crossings.

The Pledge of Allegiance was led by Boy Scout Troop 2012 and Pack 803.

3. PRESENTATIONS/ANNOUNCEMENTS

3.1 Proclamation – Red Ribbon Week, October 23-31, 2014

Mayor Pro Tem Rush presented the proclamation to representatives from the Corona-Norco Unified School District.

3.2 Certificate of Appreciation – Boy Scouts for September 11th Ceremony

Mayor Pro Tem Rush presented certificates of appreciation to Boy Scouts from Troop 2012 and Pack 803.

5.2 Benefit Assessment District No. 2014-2 (Tract 32821 & 32821-1)

RECOMMENDATION: Approve a resolution entitled:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EASTVALE, CALIFORNIA, DECLARING ITS INTENTION TO ORDER THE FORMATION OF PROPOSED CITY OF EASTVALE BENEFIT ASSESSMENT DISTRICT NO. 2014-2 (TRACTS 32821 & 32821-1) PURSUANT TO THE BENEFIT ASSESSMENT ACT OF 1982 AND IN ACCORDANCE WITH ARTICLE XIID OF THE CALIFORNIA CONSTITUTION, AND SETTING A PUBLIC HEARING THEREON

8. NEW BUSINESS ITEMS

8.1 City Council Meeting Recordings

City Clerk Donohue summarized the staff report.

8.2 Sustainable Transportation Planning Grant

RECOMMENDATION: Authorize the submittal of the Caltrans Sustainable Transportation Planning Grant for the development of Safe route to School Master Plan.

City Engineer Alvarez summarized the staff report.

Motion: Moved by Councilmember Welch, seconded by Councilmember Link to approve the recommended action.

Motion carried 4-0 with Councilmembers Link, Tessari, Welch and Mayor Pro Tem Rush voting aye and Mayor Bootsma absent.

8.3 Formation of Subcommittees for I-15 Interchange Design and Fire Station #2 Design

RECOMMENDATIONS:

1. Form an I-15 Interchange Design Subcommittee and select two members of the City Council to serve on the subcommittee.
2. Form a Fire Station #2 Design Subcommittee and select two members of the City Council to serve on the subcommittee.

Public Information Officer Nissen summarized the staff report.

Acting City Manager Van Nort noted that the Public Safety Commission should also have representatives on the subcommittees.

By consensus, the City Council ratified the following appointments:

1. Councilmember Link and Mayor Pro Tem Rush to the I-15 Interchange Design Subcommittee.

2. Councilmember Link and Mayor Bootsma to the Fire Station #2 Design Subcommittee.

9. STUDENT LIASON REPORT

Jakob Rivera, ASB President, provided an update on upcoming school activities and noted that there is an upcoming fundraiser to benefit the families of the four recent crash victims whom are alumni's of Roosevelt High School.

11. COUNCIL COMMUNICATIONS

Councilmember Link discussed a parking issue around the school areas. He suggested implementing a parking permit program.

Deputy City Engineer Indrawan stated that staff is working on the problem. He noted that several communities surrounding the high school have requested this type of enforcement.

Councilmember Welch stated that he has not been contacted by anyone concerning Mr. DeGrandpre's accusations. He acknowledged the attendance of City Council candidates. He discussed his attendance at the recent Fall Festival, candlelight vigil at Roosevelt High School, and the Walk to School Day event.

Mayor Pro Tem Rush acknowledged the attendance of Planning Commissioner Oblea, Public Safety Commissioner DaCosta, and the City Council candidates.
