 - 10.1 Chandler Community Plan

RECOMMENDATIONS:

1. Accept the Chandler Area Community Vision Plan, as recommended by the Planning Commission.

2. Adopt a notice of exemption acknowledging that accepting (or acceptance of) the Community Vision Plan is exempt from the California Environmental Quality Act (CEQA) pursuant to section 15262.

Motion carried 4-1 with Councilmembers Lorimore, Tessari, Mayor Pro Tem Link and Mayor Bootsma voting age and Councilmember Rush voting no.

<u>RECOMMENDATION</u>: Authorize Cal Fire/Riverside County Fire Department to proceed with the purchase of a new fire apparatus for the new fire station at Selby and Chandler Avenue.

Motion: Moved by Councilmember Rush, seconded by Councilmember Tessari to move the recommended action.

Motion carried 5-0 with Councilmembers Lorimore, Rush, Tessari, Mayor Pro Tem Link and Mayor Bootsma voting aye.

Motion: Moved by Councilmember Rush, seconded by Mayor Pro Tem Link to appointed Councilmember Tessari as the alternate Councilmember to serve on the Eastvale Parks Commission.

Motion carried 5-0 with Councilmembers Lorimore, Rush, Tessari, Mayor Pro Tem Link and Mayor Bootsma voting aye.
