7.1 City Council Meeting Minutes

Motion carried 3-0 with Councilmembers Lorimore, Tessari and Mayor Pro Tem Link voting aye and Councilmember Rush abstaining.

8. PUBLIC HEARINGS

8.1 Waste Management 2015-16 Rate Increase Request

RECOMMENDATIONS:

1. Approve a resolution entitled:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EASTVALE, CALIFORNIA, APPROVING THE INCREASE OF FEES AND CHARGES FOR PICK-UP AND HAULING OF REFUSE, RECYCLING AND STREET SWEEPING SERVICES WITHIN THE CITY OF EASTVALE AND APPROVING NEW FEE IN COMPLIANCE WITH AB341

2. Deny proposed damaged roll off bin charge.

City Manager Nissen introduced the item.

Senior Administrative Analyst Tran summarized the staff report. He noted that staff is now recommending to proceed with the proposed damaged roll off bin charge in specific instances of damage.

Mayor Pro Tem Link opened the public hearing.

There being no requests to speak, the public hearing was closed.

Councilmembers discussed the item and staff answered related questions.

Motion: Moved by Councilmember Rush, seconded by Councilmember Lorimore to move the recommended action as amended.

Motion carried 4-0 with Councilmembers Lorimore, Tessari, Rush and Mayor Pro Tem Link voting aye.

8.2 PROJECT NO. 14-1398 – SENDERO RESIDENTIAL DEVELOPMENT - General Plan Amendment from Medium Density Residential (MDR) to Medium High Density Residential (MHDR), Change of Zone from One-Family Residential (R-1) to Planned Residential Development (PRD), a Planned Residential Development with new development standards for the site, and Tentative Tract Map No. 36775 to subdivide approximately 45 acres into 323 parcels for single-family detached homes and 14 lettered parcels for open space and water quality basins.

<u>RECOMMENDATIONS</u>: On May 20, 2015, the Planning Commission recommended that the City Council approve the General Plan Amendment, Change of Zone, and Planned Residential Development Standards, and deny the Tentative Tract Map by taking the following actions:

- 1. Adopt an Initial Study/Mitigated Negative Declaration pursuant to the California Environmental Quality Act (CEQA); and
- 2. Adopt a Resolution approving a General Plan Amendment (GPA) from Medium Density Residential (MDR) of 2.1 to 5 dwelling units per acre to Medium High Density Residential (MHDR) of 5.1 to 8 dwelling units per acre; and
- 3. Approve the first reading of an Ordinance approving a Change of Zone from Single Family Residential (R-1) to Planned Residential Development (PRD) and adopting the PRD Development Standards for the site, subject to the attached conditions of approval; and
- 4. Deny Tentative Tract Map No. 36775.

By recommendation of the City Attorney, Councilmember Lorimore recused himself from the item because of a possible conflict of interest.

Planning Director Norris summarized the staff report and made a presentation.

Councilmembers discussed the item and staff answered related questions.

Patrick Potts, Stratham Homes, made a presentation.

Mayor Pro Tem Link opened the public hearing.

Todd Rigby, resident, expressed his concern over the number of homes being proposed on the tentative tract map.

Vincent Haydel, Southern California Edison Local Public Affairs Region Director, expressed concern over the open space design of the tentative tract map.

There being no other requests to speak, the public hearing was closed.

Councilmembers discussed the item and staff answered related questions.

Motion: Moved by Councilmember Rush, seconded by Councilmember Tessari to move recommended action #1.

Motion carried 3-0 with Councilmembers Tessari, Rush and Mayor Pro Tem Link voting aye.

Councilmembers discussed the item and staff answered related questions. It was decided that Stratham Homes would work with staff to avoid having open space on the City's public right-of-way.

10. NEW BUSINESS ITEMS

10.1 Adoption of the Annual Operations and Capital Improvement Budget Fiscal Year 2015-2016.

<u>RECOMMENDATION</u>: Approve the following resolutions for fiscal year 2015-2016:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EASTVALE, CALIFORNIA, ADOPTING AN OPERATING BUDGET AND CAPITAL BUDGET FOR THE FISCAL YEAR COMMENCING JULY 1, 2015 AND ENDING JUNE 30, 2016, AND APPROPRIATING FUNDS FOR PURPOSES THEREIN SET FORTH

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EASTVALE, CALIFORNIA, PROPOSING A PERMANENT APPROPRIATIONS LIMIT OF \$18,377,718 PURSUANT TO ARTICLE XIII (B) OF THE CALIFORNIA CONSTITUTION FOR FISCAL YEAR 2015-2016

Deputy Finance Director Montoya summarized the staff report.

1. Approve the professional services agreement with Anderson Penna for Zone 2 Storm Drain Engineering Design Services.

2. Authorize the City Manager to execute the necessary documents.

Deputy City Engineer Indrawan summarized the staff report.

Councilmembers discussed the item and staff answered related questions.

10.3 Selection of Consultant for Proposed Eastvale City Hall Architectural and Engineering Services – WLC Architects, Inc.

RECOMMENDATIONS:

- 1. Approve the professional services agreement with WLC Architects, Inc. for the proposed Eastvale City Hall Architectural and Engineering Services.
- 2. Authorize the City Manager to execute the necessary documents.

Deputy City Engineer Indrawan summarized the staff report.

Councilmembers discussed the item and staff answered related questions.

Motion: Moved by Councilmember Rush, seconded by Councilmember Tessari to move the recommended actions.

Motion carried 4-0 with Councilmembers Lorimore, Tessari, Rush and Mayor Pro Tem Link voting aye.

10.4 Amending Ordinance Relating to Establishing Speed Limits on City Streets

RECOMMENDATION: Approve the first reading of an ordinance entitled:

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF EASTVALE, CALIFORNIA, AMENDING IN ITS ENTIRETY CHAPTER 10.2 OF TITLE 10 TO THE EASTVALE MUNICIPAL CODE ESTABLISHING SPEED LIMITS ON CERTAIN STREETS

City Engineer Alvarez summarized the staff report and made a presentation.

Councilmembers discussed the item and staff answered related questions.

Motion: Moved by Councilmember Rush, seconded by Councilmember Tessari to move the recommended actions.

Motion carried 4-0 with Councilmembers Lorimore, Tessari, Rush and Mayor Pro Tem Link voting aye.

10.5 Seeking City Council Direction on Revised Landscaping Regulations

<u>RECOMMENDATION</u>: Provide direction to staff on the extent of potential changes to the City's landscaping regulations to assist in regional efforts to conserve water during the ongoing drought.

Planning Director Norris summarized the staff report.

Councilmembers discussed the item and staff answered related questions.

By consensus, the City Council decided to follow the standards of the Jurupa Community Services District (JCSD) in relation to the drought.

11. CITY MANAGER'S REPORT

City Manager Nissen stated that the City received a grant through the Riverside County Transportation Commission (RCTC) SB821 that would provide sidewalks on Hamner Ave between Mississippi Drive and Schleisman Avenue and on Citrus Avenue between Scholar Way and Eastvale Community Park and a handicap landing and ramp on the southeast corner of Schleisman Avenue and Sumner Avenue.

Councilmembers discussed a potential sidewalk on Limonite Avenue between Scholar Way and where the Ralphs shopping center begins. Staff stated that they are in conversation with property owner to find a solution.

City Manager Nissen thanked the City Council and staff for all their hard work on the budget.

12. CITY COUNCIL COMMUNICATIONS

Councilmember Lorimore congratulated the recent graduate class of high school seniors. He congratulated Orange Theory Fitness on their grand opening. He discussed a recent Southern California Association of Governments (SCAG) meeting and a recent tour of the Jurupa Community Services District (JCSD) Water Treatment Plant. He noted that he is looking forward to the Western Riverside Council of Governments (WRCOG) General Assembly that will take place on June 11, 2015.
