<u>RECOMMENDATION</u>: Adopt a resolution to change Schleisman Road to Riverboat Drive between Scholar Way and Wells Springs Street; and "A" Street to Schleisman Road between Hamner Avenue and its Westerly Terminus, entitled:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EASTVALE, CALIFORNIA, TO CHANGE SCHLEISMAN ROAD TO RIVERBOAT DRIVE BETWEEN SCHOLAR WAY AND WELLS SPRINGS STREET; AND "A" STREET TO SCHLEISMAN ROAD BETWEEN HAMNER AVENUE AND ITS WESTERLY TERMINUS

10.2 Preliminary Budget Hearing Date

RECOMMENDATION: Select a date to hold a preliminary budget hearing.

Councilmembers discussed the item and staff answered related questions.

By consensus, the City Council decided to hold the preliminary budget hearing as a Special Meeting on May 13, 2015 at 5:00 p.m.

11. CITY MANAGER'S REPORT

Interim City Manager Nissen stated that Cal Fire crews are currently cleaning the future City Hall site on Hamner Avenue and Schleisman Road and the perimeter of the Leal property on Limonite Avenue and Hamner Avenue.

12. CITY COUNCIL COMMUNICATIONS

Councilmember Tessari congratulated Sharyn Link and Michael "Ozzie" Osborn on their recognitions. He asked if a representative from the Jurupa Community Services District (JCSD) could attend a future City Council meeting to discuss any new programs pertaining to the drought. He noted that the City should look into temporarily suspending enforcement on landscaping.

City Attorney Cavanaugh stated that staff will be presenting policy on the suspension of landscaping at a future City Council meeting.

Councilmember Lorimore discussed a recent water symposium that he attended. He noted that he attended a retirement dinner for a Los Angeles Police Department (LAPD) officer who is a resident of the City of Eastvale.

Councilmember Rush reiterated Councilmember Tessari's thoughts on the drought issue.

Mayor Pro Tem Link asked if Nationwide Cost Recovery Services would be able to aid residents in obtaining new grass.

Nef Cortez stated that they could help collaborate with water agencies to refund a portion of the new grass.

Mayor Bootsma thanked Eastvale police for their work on bicycle helmet enforcement. He encouraged the community to sign up for e-notification on the City's website.
